**FACTS Peace of Mind (POM) Tuition Protection Plan** – Anyone enrolling in FACTS to have their tuition automatically withdrawn is required to purchase Peace of Mind Protection Plan. FACTS will pay the remaining unpaid balance on your FACTS Agreement (except payments in arrears) to your school in the event of the death of the responsible party or his/her legal spouse. Coverage begins when the fee for POM has been paid to FACTS.

I agree to pay a nonrefundable annual fee of \$22.50 per FACTS Agreement.

For those returning to FACTS, your bank information will be carried over from last year's FACTS Agreement. **Please provide a voided check/savings account number if your financial information has changed.** Adjustments for financial assistance/scholarships/other awards will be made directly by the rectory office.
